

# HOUGHTON MIFFLIN LICENSE AGREEMENT

Before using this product, you should carefully read the following questions and answers. Using this product indicates your acceptance of the terms and conditions contained in the answers. If you do not agree with them, you should return the product and your money will be refunded.

**Q: WHAT DOES THIS PRODUCT INCLUDE?**

A: This product includes compact discs; software recorded on the discs; contents delivered by the software; and printed documentation.

**Q: HOW MAY I USE THE PRODUCT?**

A: You may use the product as follows:

You may print, transmit or modify the contents only for your individual or class use. The product identifies any contents owned by rights holders other than Houghton Mifflin Company and you may only use those contents in accordance with current copyright law.

You may only install the software onto a single computer for use on that computer, except for the student database, which you may install on a network server.

You may not remove or obscure any copyright, trademark, proprietary rights, disclaimer, or warning notice included on or embedded in any part of the product.

It is illegal to reverse compile, reverse assemble, reverse engineer, modify, or merge the software. You may not create derivative works based upon the software in whole or in part.

**Q: MAY I USE THE PRODUCT ON MORE THAN ONE COMPUTER?**

Houghton Mifflin Company grants you a license to use the software and its contents in accordance with the terms and conditions set forth in this License Agreement. Houghton Mifflin Company and its licensors own and retain all title, copyright, trademark, and other proprietary rights in and to the software and its contents.

**Q: MAY I GIVE THE PRODUCT TO ANOTHER PERSON?**
